## **Governance and Development**

Kathleen Zimmermann discussed NYOS' AYP (Adequate Yearly Progress) standings. NYOS met the requirements of AYP. Only 28% of Texas schools meet the standards.

Kathleen Zimmermann updated the council on the facility planning. Offices will move from building D to the Kramer campus while they are renovating. We are currently finalizing plans for building D and working on adding 12 new parking spaces to the Lamar campus.

NYOS hosted a tour at the Kramer campus for the Texas Sunset Commission last week.
