THIS MEETING WAS CONDUCTED BY VIDEO CONFERENCE IN ACCORDANCE WITH THE GOVERNOR'S AUTHORIZATION CONCERNING SUSPENSION OF CERTAIN OPEN MEETING LAW REQUIREMENTS FOR THE COVID-19 DISASTER.

Urgent public matter.

In accordance with Texas Government Code Chapter 791, NYOS had the opportunity to participate in Project Connectivity, a statewide co-op for bulk pricing on technology needs for at-home learning, and reimbursement for technology monies already spent, in response to the COVID 19 disaster. Participation requires Board approval of the inter-local agreement with ESC IV, the project manager, with a strict deadline of August 4. Management has requested that the Board approve this agreement. Management's request for this approval, the opportunity for this funding reimbursement and purchasing power, and the imminent deadline constitute a situation where "...immediate action is required of the Board because of... a reasonably unforeseeable situation." And hence, in accordance with Texas Gov Code §551.045, an emergency meeting is called for this purpose.
